Her approach was forward-looking and innovative, always aimed at elevating industry practices and standards. Margaret was constantly searching for ways to improve and grow the strata sector, showing us all what it means to embrace change and inspire progress.

Her *community impact* was equally remarkable. Margaret was deeply committed to the community, actively working to make a meaningful difference. She brought people together, building networks and encouraging collaboration, all while promoting the association's goals. Her contributions fostered unity, professional development, and a sense of belonging, which are lasting gifts to the industry.
